As required by Title 13 of the Nisqually Tribal Code, you have the following options to cast a vote in these important elections:

1. In-person at the general election via written ballot; or
2. By Absentee Ballot if you are not available to vote in person on May 2, 2020, you may vote by Absentee Ballot according to Article IV, Section 2 of the Nisqually Constitution.

To vote by Absentee Ballot please follow the instructions on the Absentee Ballot Request Form:

- Complete the Absentee Ballot Request Form by **April 12, 2020** – available at the Tribal Center or on the website. Follow the instructions on the form.
- Submit the Absentee Ballot Request Form to Honest Ballot

  - Place the completed form into the locked mailbox at the Tribal Center.
- Honest Ballot will send you an Absentee Ballot for the general election.
- The completed **Absentee Ballot** must be returned by mail no later than May 2, 2020 or deposit the envelope in the locked mailbox at the Tribal Center no later than closing of the polls **5:00 PM on May 2, 2020.**
