#### STAY AT HOME ORDER SUMMARY

# Due to the COVID-19 public health emergency, a Stay at Home Order is now in effect on the Nisqually Indian Reservation.

## What does the order say?

- You must stay in your home at all times, except for essential activities.
- You may not gather in groups outside of your household.
- Outside of your residence, you must maintain social distancing of at least six (6) feet from any other person.
- If you are sick or at high risk of illness, you must stay in your residence except as necessary to seek medical care or essential services.

## Is the order voluntary?

No. You must comply with the order. Violation of or failure to comply with the order shall result in a fine, detention, or both.

# To whom does the order apply?

All individuals currently living within the exterior boundaries of the Nisqually Indian Reservation ("Reservation") are ordered to stay at home.

# What business activity will continue on the Reservation?

- Healthcare Operations at the Nisqually Clinic
- Essential Departments at the Tribe will continue operations on a very limited basis to address the urgent needs of tribal members. <u>Please call the Tribal Administration</u> <u>Building to reach a particular department or request services. Departments that provide critical services will remain open.</u>
- Nisqually Markets and gas stations
- Nisqually Post and Print

When may I travel outside of my home? You may leave your home <u>only</u> to engage in essential activities, which include:

- To attend medical appointments or obtain medical supplies
- To obtain supplies you need to work from home

- To obtain necessary services or supplies for yourself or your family
- To deliver supplies to others or to provide essential services to others
- To engage in outdoor activity if you can comply with social distancing guidelines
- To perform work that has been deemed "essential" by the Nisqually Tribe
- To care for a family member or pet.
- To engage in treaty fishing and hunting rights
- To engage in necessary employment <u>off</u> the Reservation if your employer is still requiring individuals to report for duty.
- To travel to or from educational institutions for purposes of receiving materials for distance learning, for receiving meals, and any other related services.
- To travel to or return to a place of residence from outside the Reservation.
- To return to your place of residence outside the Reservation.

### How will the order be enforced?

Please help keep our Tribal members safe by complying with the order voluntarily. These measures are critical if we are to keep the COVID-19 virus from spreading in our community. If necessary, the Nisqually Police or the Nisqually Public Health Officer will enforce this Order. Violations of may subject you to a fine of up to \$10,000 per day and possible detention.

**How long is the order effective?** March 24, 2020, at 6:00 p.m. through April 30, 2020, at 6:00 p.m., unless extended by Tribal Council or the Nisqually Public Health Officer.
