Honest Ballot hereby certifies <u>291</u> votes were cast and tallied in the Primary Election for the officers of Tribal Council Chairman, Tribal Council Secretary, Tribal Council 5th Member, Sergeant-At-Arms, and Fish Commission on Saturday, March 13, 2021 at Billy Frank Jr. Gymnasium on The Nisqually Tribal Center. The <u>291</u> tallied ballots do not include <u>3</u> absentee ballots that were submitted without a copy of the voter's ID and therefore could not be counted pursuant to Title 13 of the Nisqually Tribal Code. In accordance with § 13.02.07(d), (e), (f), and (g) of the Nisqually Elections Ordinance, the top two candidates with the highest votes will advance to the General Election on May 1, 2021.

IMPORTANT NOTE:

In accordance with 13.02.07(g), There will be no General Election for any Fish Commission position. The top five candidates who received most votes at the Primary election are declared the winners.

In accordance with 13.02.07 (e), Enrollment Committee Chair has only one (1) candidate, therefore the position was not included in the primary election. The single candidate is instead the declared winner after the completion of the Primary Election on March 13, 2021. "Andrew Squally Jr" is the declared winner for Enrollment Committee Chair.

In accordance with 13.02.07(f), as there are only two candidates for an open Enrollment Committee Secretary, Fifth Member, and only three (3) candidates running for 2 positions for Shareholder (2 Year Term), these positions were advanced to the General Election. These positions did not need to be voted on in the Primary Election because the candidate pools did not need to be narrowed down.
