- 1. In-person at the Special Election via written ballot; or
- 2. If you are not available to vote in person on July 10, 2021, you may vote by Absentee Ballot according to Article IV, Section 2 of the Nisqually Constitution.

To vote by Absentee Ballot please follow the instructions below:

- > Complete the Absentee Ballot Request form by June 20, 2021- available at the Tribal Center or on the website. Follow the instructions on the form. It was also sent to all eligible voter via mail.
- ➤ Submit the Absentee Ballot Request Form to Honest Ballot

  - ➤ Place the completed form into the locked mailbox at the Tribal Center.
- ➤ Honest Ballot will be sending an Absentee Ballot for the special election.
- ➤ The completed <u>Absentee Ballot must be received</u> by mail no later than July 10, 2021 or deposit the envelope in the locked mailbox at the Tribal Center no later than closing of the polls at 5:00 PM Pacific on July 10, 2021.
