NISQUALLY ELECTION ATTORNEY - REQUEST FOR PROPOSALS

The Nisqually Indian Tribe seeks proposals from qualified attorneys and law firms interested in fulfilling the role of “Election Attorney” as described in Title 13 of Nisqually Tribal Code (“Elections”) during the Tribe’s 2027 election cycle. The Tribe’s seat of government is located on the Nisqually Indian Reservation near Olympia, Washington.

SCOPE OF WORK:

The primary duty of the Election Attorney is to advise the Tribe’s 3rd party election auditor regarding election-related legal issues, including:

- Advising the third-party election auditor in any election protest or legal matter arising from the election.
- Investigating charges of election irregularities submitted in accordance with the election protest process.
- Rendering written findings of fact and conclusions of law to the third-party election auditor in any election protests.
- Assist the 3rd party auditor with any election contests or legal matter arising from the elections.
- Performing other duties of the Election Attorney described in Title 13 of the Nisqually Tribal Code (Elections).

The Tribe’s 2027 election cycle begins in February and concludes in May. The work is on a part-time, contractual basis, for a one-year term beginning no later than February 1, 2027.

PROPOSAL REQUIREMENTS:

Proposals should be no more than 3 pages and must address the following elements:

- 1) The firm’s experience working in Indian Country including any prior experience with Tribal elections.
- 2) Tribal court bar admission, if any, and competence to practice in Nisqually Tribal Court
- 3) The experience and qualifications of the individual attorney(s) proposed for the work.
- 4) Hourly rates for attorneys and support staff proposed for the work.
- 5) Three references (Tribal Government references preferred but not required).
- 6) Statement of Native American Preference qualifications, if applicable.
