### To Apply for Support:

Please read the general guidelines below to determine if your organization qualifies for Charitable funds.

### Application:

Each organization will only be allowed one application per year.

### To Qualify for Charitable Funds:

The organization must be registered as a 501 (c)(3) tax exempt status with the IRS and be in Washington State. (Please note that Thurston County will be the priority when funding, other counties will be funded as funds allow.)

### Guidelines:

- Address on the application must match the W-9
- Official documentation is required of your 501 (c)(3) status.
- All applications are due July 31, 2024
- Official applications will only be accepted via email or USPS.
- Prior year recipients must provide a narrative of how funds were utilized and pictures where applicable.

### Check List:

If all items on the checklist are not received, no notification will be made, and your application will not be accepted. Please double check all documents prior to submission to ensure you have turned in a complete packet.

- Attached 501 (c)(3) status verification form.
- W-9 form with current address.
- Completed Application (no more than 4 pages front and back.)
- Prior year recipients must provide a narrative of how funds were utilized and pictures where applicable.
